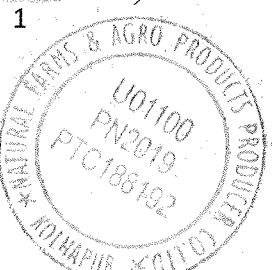

MEMORANDUM OF UNDERSTANDING (MOU)





This MOU is made and entered into at, Kolhapur, on the date 9th December, 2022.
BETWEEN: Vivekanand College, Kolhapur (Autonomous), having its address at, Tarabai Park, Kolhapur, Maharashtra 416 003, and Natural Farms & Agro Products Producer Company Ltd. registered office at 1672, 'E' Shriram Housai, 10th Lane Rajarampuri, Kolhapur, Maharashtra- 416008, here with referred as (Natural Farms which expression shall mean and include their representatives and administrators)



7. Natural Farms shall nominate, Director Mr. Abhijeet Patil as a Point of Contact (POC) while Vivekanand College will nominate Dr. Revati R. Patil, Coordinator of the BBA Department as POC for proper operation of MOU.
8. Both the parties will make available library facilities, handbooks and other relevant literature and research facilities to each other strictly for academic purpose and with mutual consent as and when requested.
9. Natural Farms shall provide their expert manpower for academic benefit of students, Faculty Development Programs, seminars, Curriculum development and Syllabus Review Committee as per their convenience and request from Vivekanand College.
10. Natural Farms shall allow the students to visit the plant/s or sights for the purpose of field visit or Study Tour if there is an academic requirement of the course.
