- **BOS/09/01:** The Chairman requested the attendees to review the minutes of the 8th BOS meeting held on 27-6-2022. After a thorough review, the minutes were approved by the members.
- BOS/09/02: Discussion of Revised Syllabus (70-30) for Third Year B.Sc. Computer Science (Science Faculty) Sem-V and VI. The Chair opened the floor for discussions on the revised contents of the syllabus for Third Year B.Sc. Computer Science (Science Faculty) for Sem-V and VI. The attendees provided their inputs and suggestions regarding the proposed changes. After a detailed discussion, it was resolved that the revised syllabus would be implemented from AY 2023-24, pending final approval from the concerned authorities.
- BOS/09/03: The attendees engaged in a thorough discussion regarding the revised contents of the syllabus for First Year M.Sc. Computer Science (Science Faculty) for Sem-I and II. Various aspects of the proposed changes were deliberated upon, and feedback was shared by the attendees. After careful consideration, the revised syllabus was finalized and would be implemented from AY 2023-24.
- BOS/09/05: The meeting also involved a discussion on the percentage of proposed change in the syllabus for the respective courses. A consensus was reached to aim for a reasonable percentage of change while ensuring continuity and foundational knowledge.
- BOS/09/06: The Chair opened the floor for any other matters to be discussed. Several topics were raised, including MOOC courses, faculty training programs and research collaborations. These matters were briefly deliberated upon and it was decided to include them in the agenda for future BOS meetings to ensure comprehensive discussions and follow-up actions.
