MEMORANDUM OF UNDERSTANDING

Vivekanand College Kolhapur

and

Society for Mathematical Engineering, Kolhapur

This memorandum of understanding is made at Kolhapur on Thursday, 12 September 2019.

In order to promote academic co-operation and exchange, the Vivekanand College, Kolhapur and Society for Mathematical Engineering, Kolhapur agree to the following Memorandum of Understanding (MOU).

The Objectives of MoU are.

1. Free institutional membership will be given to the college.
2. To promote and enhance academic interest.
3. To provide advice for implementation of quality education.
4. Encourage students of either institute to attend lecturer in the other institute during lecturer session, seminars and conferences.
4. To conduct joint supervision of research projects.
5. To provide facility of training and placement at institute.

Proposed Models of Collaboration:

1. To exchange faculty.
2. To undertake student exchange programme.
3. To guide student for project.
4. To avail digital library facilities to the sme member of faculty & Student.
5. To organize other academic and social activities.
6. To organize combine visit to scientific places.

Chapter:

Society for Mathematical Engineering can operate SME student chapter.

Terms and Conditions:

1. This MoU may be amended, renewed and terminated by mutual written agreement of the institution at any time.
2. Either institution shall have the right to terminate this MoU upon 60 days prior written notice to the other institute.

Duration of MoU:

This MoU, unless extended by mutual written consent of the institute, shall expire in FIVE YEARS after the effective date specified in the opening paragraph. However, on review the MoU shall be extended for another five years by mutual consent.

Coordinators:

Both institutions will designate persons who have responsibility for co-ordination and implementation of this agreement.

This Memorandum of Understanding to be executed, effective as of the day and year of MoU.




