Notice of Meeting



**Item No. 1: Confirmation of the minutes of the last meeting.**

**Item No. 2 : To finalize syllabi of all the papers of the BA III (Political Science), Semester V and VI to be introduced from the academic year 2020-21.**

[Note: According to structure of the papers (courses) of BA III (Political Science), that is Semester V and VI, that was finalized in the last meeting, the contents of all the papers were discussed one by one. Suggestions made by Dr. Bharati Patil were incorporated into syllabi. After discussion, the syllabus of each paper was finalized. ]

Resolved that, the finalized syllabi will be proposed to the Academic Council for sanction, to be implemented from the academic year 2020-21.

**Item No. 3 : To decide the examination system and structure of question paper for BA III.**

[Note: The examination system and structure of question paper proposed by the BoS Chairman were discussed by the members and the same were finalized.]

It was decided that the structure of question paper and the modes of internal evaluation for BA III (Political Science) courses are finalized as part of the curriculum and will be presented to the Academic Council for sanction.
