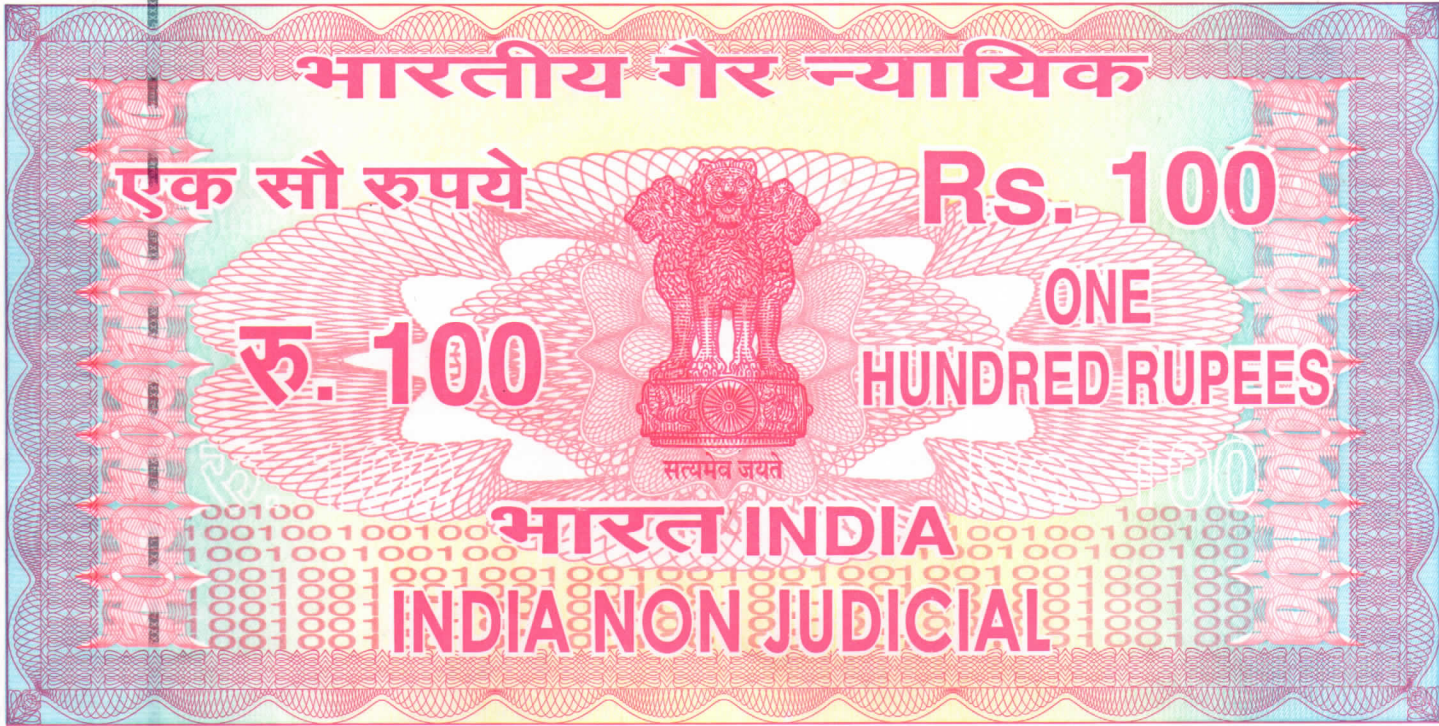

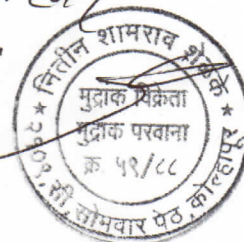

### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered into on this 7<sup>th</sup> December 2022 by and between, the following parties -

- 1) **VIVEKANAND COLLEGE, KOLHAPUR**, 2130, E Ward, Tarabai Park, Kolhapur, Maharashtra 416003, by Dr. R. R. Kumbhar, being the principal of the College, here in after referred to as the COLLEGE, being the party of the first part; and
- 2) **M/S. NOKARI MAHAMANDAL**, a proprietary concern, through its proprietor Mr. DHAVAL RAJAN CHOUGALE, having its registered address: 645, E ward, Shahupuri,



1<sup>st</sup> lane, Kolhapur, Maharashtra, Pin – 416001, here in after referred to as Nokari Mahamandal, being the party of the second part.

Whereas the College is an educational institute and has been affiliated to Shivaji University and has been conducting various degree and diploma courses of the said University since many years and NOKARI MAHAMANDAL has been working in the area of providing jobs to the needy persons, with or without the required training. NOKARI MAHAMANDAL is one of the group companies of Modern School of Computers and this group has been involved in providing computer knowledge and job placement services to the students since last 30 years. NOKARI MAHAMANDAL has offered its job placement/assistance services to the students of the College and the College has been interested in providing such services to its students.

**A. Objective:** This MOU between VIVEKANAND COLLEGE, KOLHAPUR and NOKARI MAHAMANDAL, Kolhapur is made for the following main purpose:

- a. To provide all the students, the on-line job placement services,
- b. To provide necessary training & skill development programs
- c. To run efficiently a job placement service centre in the college premises.

**B. Roles and Responsibilities:**

1) **Nokari Mahamandal** agrees that it will provide the following services and facilities to your students.

1. **On-Line Job Portal** - All the students of the College will be registered on the on-line job portal maintained by **Nokari Mahamandal**.
2. **6000+ Local Companies** - **Nokari Mahamandal's** on-line job portal will be visited by more than 6000 local companies will be searching for the identifying the suitable candidates.
3. **On-Line Campus Interviews** will be arranged by **Nokari Mahamandal**. To face such interviews and the students will be given sufficient training for this purpose.
4. **College Login Password** - The College will be given the login password for the on-line job portal, so that the College can see all the data relating to their students.
5. **Students' Login Passwords** - All the College students will be given their personal login passwords for the on-line job portal, so that they can see the on-line data and also they can update the bio-data on their own.

6. **Single Window Placement Service - Nokari Mahamandal** will establish a service centre in your College premises so that a "Single Window Placement Service" could be provided to your students.
7. **Job Board** – A board will be displayed near the **Nokari Mahamandal** Service Centre showing the local jobs available and the data so displayed will be updated from time to time. This will help the desiring students to get employed while learning or otherwise.
8. **Career Guidance - Nokari Mahamandal** will arrange career guidance and programs for your students.
9. **Personality Development & Interview Techniques** - NOKARI MAHAMANDAL will arrange Personality Development & Interview Techniques programs for your students.

**II) The College** will, in turn, agree to perform the following functions and provide the resources as under but it is not mandatory:-

1. A small room for the **Nokari Mahamsandal** Service Centre shall be provided by the College and a place for displaying the **Job Board** which could be easily viewed by students,
2. A person working part-time ( 4 hours a day ) to take care of this Centre,
3. A computer, a printer and an internet connection, and
4. The placement assistance service will be offered to your students free of cost. However, the cost of honorarium payable to expert invitees to conduct various training workshops for the students will be payable by the participating students. This amount shall be taken from each student at the time of participating a training workshop.

**C. Reporting Requirements:**

The Company will be responsible for collecting, collating and submitting data as per the project target outputs and outcomes.

**D. Timeframe:**

This MOU will commence on and from 17. December 2022 and it will be effective for the 5 full academic years and thereafter it may be continued by the mutual consent of the parties.




**F. Confidentiality:**
