Whereas, both Party A and Party B recognize the value of academic and research collaboration and wish to establish a formal framework for cooperation;

Now, therefore, Party A and Party B hereby agree as follows:

1. Purpose of Collaboration:

- Party A and Party B intend to collaborate in the areas of academic and research activities, with a focus on Chemistry.

2. Duration:

- This MoU shall commence on 01/12/2023 and remain in effect for a period of (5 Years) unless terminated or extended as provided herein. It may also be extended, if it has not been terminated prior to expiry of the five years, if both parties so agree.

3. Areas of Collaboration:

The collaboration may encompass, but is not limited to, the following areas:

- Research:** Joint research projects, research publications, and grant applications.
- Academic Exchange:** Faculty and student exchange programs.
- Educational Programs:** Development of joint educational programs or courses.
- Workshops and Seminars:** Organizing and participating in workshops, seminars, and conferences.
- Resources:** Sharing of academic and research resources and facilities.
- Community Engagement:** Collaborative community engagement and outreach projects.
- Other:** Any other areas mutually agreed upon by Party A and Party B.

4. Responsibilities:

- Each party shall outline its specific responsibilities and contributions to collaborative projects, including funding, personnel, and resources.

5. Governing Body:

- The collaboration shall be overseen by a Joint Steering Committee consisting of representatives from Party A and Party B. The Committee shall meet (biannually) to review progress and make decisions regarding collaboration activities.

6. Funding and Resources:

- The parties shall determine the allocation of financial and other resources required for collaborative activities on a project-by-project basis.

7. Termination and Amendment:

- This MoU may be terminated by either party with (Thirty (30) days) written notice to the other party. Amendments to this MoU shall be made in writing and signed by both parties.

8. Confidentiality:

- Both parties agree to maintain the confidentiality of any non-public information shared during the course of collaboration.

9. Execution:

- This MoU shall come into effect upon the signatures of authorized representatives of Party A and Party B.
