This endeavor arises from the recognition of a pressing need for advanced and well-equipped CAP centers in the Kolhapur region, considering the limited availability of such facilities nearby. The establishment of this Digital CAP Center underscores our commitment to providing an accessible and efficient platform for the examination paper assessment process.

Objectives:

- **Localized Assessment:** The primary objective of setting up the YCMOU CAP Center is to localize the examination paper assessment process for YCMOU in the Kolhapur region. This addresses the challenges faced by evaluator who would otherwise have had to travel long distances to access CAP centers.
- **Efficient Evaluation:** By hosting the CAP Center locally, our college aims to streamline the evaluation process, ensuring timely and efficient assessment of examination papers. This contributes to the overall effectiveness and integrity of the YCMOU digital assessment system.
- **Evaluator Convenience:** The establishment of the CAP Center at our college enhances the convenience for YCMOU evaluator in Kolhapur, providing them with a nearby location for the assessment of examination papers. This digital CAP, in turn, reduces the logistical burden and promotes a more user-friendly evaluation process.
- **Increased Capacity:** The CAP Center expands the capacity for examination paper assessment in the region, accommodating a larger number of YCMOU papers.

AGREEMENT

This agreement is made on this day of 1st June, 2019 between service provider designated by YCMOU, Nashik in Examination Management Systems, M/s Magnetic Infotech Private Limited having registered office at No 24, Nagarjuna Hills, Panjagutta, Hyderabad, Telangana herein after called MIL as one part

represented by the Principal / Coordinator / Head of the Institution on the other part, here in after called the "Digital CAP Center". This agreement is effective from **1st June 2019** and valid up to **31st May 2020**, inclusive of Sundays and holidays.


1. As per the directions of YCMOU, Nashik, 'MIL' has approached the above said 'Digital CAP center' for utilizing the facilities for Central Assessment Programme (CAP) through online evaluation of Answer Script. The facilities include computer systems (minimum 25 systems), LAN, UPS and Internet bandwidth static IP and other infrastructure.
2. The 'Digital CAP Center' has agreed to provide such facilities to YCMOU for online evaluation and the service provider 'MIL' will act on behalf of YCMOU in executing the on-line evaluation. Payment for utilizing the facilities and honorarium for the administrative and technical personnel of the 'Digital CAP center' will be made by MIL.
3. YCMOU shall pay the evaluation charges directly to the evaluators on the basis of Answer script evaluated by the respective evaluators.
4. MIL shall pay to the 'Digital CAP Centers at the rate of Rs.4.00 (Rupees Four only) per answer (script) evaluated for utilizing the facilities. (PAN card details is essential). CAP Center Head (CAP director) shall be paid Rs. 0.40 (Rupees Zero and Paisa Forty only) per answer sheet (script) valued for making effective and maximum evaluation. It is expected that CAP Center Director should be able to mobilize minimum 25 evaluators per shift (morning and evening) from the list of evaluators provided to them by the Regional Directors. The above Digital CAP Center charge include remuneration of the staff developed by the CAP center excluding of CAP center in-charge.
5. The Prospective CAP Center should enroll with the YCMOU web portal with the facilities available with them and facilities offered for YCMOU Central Assessment Programme.
6. YCMOU shall make the list of evaluator available to 'Digital CAP Center- in-charge'. YCMOU shall issue appointment orders and give messages to all the evaluators to attend evaluation and can approach assigned Digital CAP center.
7. The Digital CAP Center Head (CAP Director) shall follow with the evaluators through SMS/emails/Telephone calls and make them to attend the evaluation work.
8. MIL shall train the evaluators on the usage of software through online/ CBT training.
9. The Digital CAP Center head (CAP Director) should ensure the security arrangements both physical and data security during evaluation work.
10. The 'Digital CAP Center-Director shall verify the identification of the evaluators before admitting and assigning the evaluation work. The Director should also maintain physical attendance register and promptly submit the same to the Controller of Examinations of YCMOU.

11. YCMOU allows maximum of 100 Answer sheets(scripts) to be valued per day per Evaluator. if any change it will be intimated by YCMOU.
12. Digital CAP center should be actively involved in On-screen evaluation till the evaluation activity is completed. If any CAP center wishes to withdraw from this activity, they should take prior permission from YCMOU in writing.
13. The following manpower should be deployed by the Digital CAP center, and they should be available for the two shift operation
 - Digital CAP Center in-charge
 - Hardware Technician
 - Network Administrators
 - Other Supporting staff
14. If Cap center violates any rules and guide lines prescribed by YCMOU, legal action may be initiated against them and further all payments due to them will be withdrawn
15. MIL will provide 2 biometric devices for each CAP center for Biometric Recording and authentication during evaluation through Regional center, After completion of event the Cap Director has to return back the biometric devices to regional center.
16. Once the agreement is done, no change in any details are allowed.
