1. Compensation

You shall be paid INR 7,700/- per month as consolidated salary . Income Tax and other government taxes, as may be applicable, will be borne by you and would be deducted from your salary / stipend.

As per the regular attendance bonus policy (if applicable), you will be given 15 days salary as bonus on your regular attendance. And if you work regularly in the company for two years, you will get a one time loyalty bonus of Rs. 14,400/- after two years.
