**Item No. 1 : To confirm the minutes of the previous meeting.**

The member secretary Dr. S. M. Joshi read out the minutes of the previous meeting held on 21<sup>st</sup> May 2018 and the minutes were confirmed. The action taken report was also read out by the secretary and it was confirmed.

**Item No. 2 : To scrutinize and approve the proposals of the BoSs with regard to the syllabi of UG courses.**

The chairperson of the meeting asked all 24 BoS chairmen to present the newly framed syllabi of second year of BA, B.Com., B.Sc., BBA, BCA, BCS, B.Sc. Biotechnology through PPT for the perusal of the honourable members of the Academic Council. Accordingly, 24 BoS chairmen presented their syllabi one by one. The honourable members



Of the Academic Council gave their valuable suggestions wherever required and the final approval was given unanimously to the said syllabi.

**Item No. 3 : To approve the syllabi of BoSs with regard to the syllabi for PG Diploma and PG courses.**

The chairman of the committee again asked the concerned BoS chairmen to present the syllabi for the PG diploma and PG courses to be conducted from the Academic Year 2019-20. The BoS chairmen of English, Chemistry, Physics, Mathematics and M.Com. presented their newly formed syllabi for PG diploma and PG courses. The honorable members of the Academic Council gave valuable suggestions wherever required and the final approval was given unanimously.

**Item No. 4 : To define policy for the promotion of research in the college.**

The honourable chairman of the Academic Council informed that the college has taken initiatives like providing seed money for major and minor research projects by the faculty members. He also informed that during this academic year (2018-19), seven teachers have been given Rs. 25000/- each for their research projects. Dr. S. S. Mahajan, University Representative, suggested to establish incubation center of the college. The Principal informed that the process of incubation center has already been started in collaboration with BioEra of Pune. It was unanimously decided that all faculty members should be motivated to undertake research projects. Dr. Madhukar Bachulakar suggested to undertake interdisciplinary research projects. Dr. S.S. Mahajan suggested to have research ethics in the research policy. Dr. A. N. Jagtap suggested to focus on PG level students and to motivate them to write review articles from which potential project ideas can be derived.

**Item No. 5 : To approve the syllabi of add-on and certificate courses.**

The chairmen of the Academic Council asked the BoS chairmen to present their newly formed syllabi for add-on and certificate courses of the department to be implemented from the academic year 2019-20. Accordingly, all BoS chairmen presented their syllabi for add-on and certificate courses through PPT unanimously. The proposed courses are :

**Item no.6 : To discuss changes in the evaluation system according to POs, PSO, Cos.**

The honourable member of the Academic Council Dr. M.M. Karanjkar presented before the council the changes to be taken into consideration in the evaluation system according to POs, PSO, Cos. Some of the members raised their difficulties and doubts and the concerned difficulties and doubts were cleared by Dr. Karanjkar.

Prin. Dr. S. Y. Hongekar informed that 80-20 pattern of evaluation has been accepted by the college and every BoS has been given the freedom to decide the nature of internal assessment according to their expected learning outcomes.

**Item No. 7 : Any other matter with permission of the Chair.**




A. **Compulsion of certificate courses:** Prin. Dr. S. Y. Hongekar suggested to make compulsion of certificate courses to all the students and the required fees to be collected at the time of admission only. Mr. Surendra Jain seconded this suggestion but Dr. Jagtap suggested to take feedback from the outgoing students whether college should make compulsion of certificate courses to all the students and on the basis of feedback by the students, the final decision should be taken in the Governing Body of the college. All the honourable members unanimously agreed to this suggestion.

B. **Interdisciplinary CoC:** Dr. S. S. Mahajan suggested to have interdisciplinary CoCs wherever possible. All the members unanimously agreed to this suggestion.

**Item No. 1: Confirmation of the minutes of the last meeting.**

The minutes of the previous meeting held on 14<sup>th</sup> July 2020 were read by the member secretary Dr. Shruti Joshi along with the action taken report. The minutes were confirmed by the members.

Because of the special pandemic situation, the new postgraduate programmes could not be run from the current academic year.

The coordinators of these centers (Shikshanmaharshi Dr.Bapuji Salunkhe Study Center, Chhatrapati Shahu-Phule-Ambedkar Study Center, Dr. A P J Abdul Kalam Study Center) have been appointed.

7	To discuss about applying for Women's Studies Center.	Sansthamata Sushiladevi Salunkhe Center of Women's Studies has been established and inaugurated. A RUSA sponsored national seminar on the theme "Transcending the Boundaries of Gender" was organized by the Center on 22 January 2021.

**Item No. 2: To discuss the course structure of all Part I courses to be implemented from the Academic Year 2021-22.**

The Dean of Arts and Commerce Faculty Dr. S. R. Kattimani and the Dean of Sciences Dr. M. M. Karanjkar presented before the committee the CBCS course structure and the alterations therein to be implemented from the Academic Year 2021-22.



Dr. S. R. Kattimani proposed the new pattern of internal assessment for BA programme. It was proposed that the 10 marks in the 40:10 division of CIE and Semester end examination will be converted from 30 marks' internal examination; the CIE for BA programme will consist of two tests (10 marks each) and a skill oriented activity (Semester I: Summary writing /note-making, Semester II : Book review / film review) (10 marks).

Dr. M. M. Karanjkar presented the conversion of one 80 mark paper into two 40 marks' papers of each course in the B.Sc. programme.

The Chairpersons of respective Boards of Study presented the draft syllabi of their Part I courses. The external members in the Council gave suggestions for the same.

It was resolved that the changes proposed in the CIE of BA programme and the course structure of B.Sc. programme are sanctioned and will be introduced from the academic year 2021-22.

**Item No. 3: To sanction the implementation of M.Voc. Courses.**

The Chairperson of B.Voc.(Graphic Design) Mr. Satish Uplawikar and Mr. Abhijit Mane of Foundary Technology presented the syllabi of M.Voc. Part I courses.

The committee sanctioned the implementation of M.Voc. Courses from the current academic year.

**Item No. 4: To finalise research and consultancy policy.**

Dr. Shubhangi Kale, the Chairman of Criterion III presented the research and consultancy policy prepared by the Research Committee of the college.

Dr. Delekar suggested that the college should provide funds to the faculty members for filing patents and it should be mentioned in the Research Policy. Dr. S. H. Thakar suggested that after production of the Patented research, certain percentage of the profit should be shared with the institution by the faculty member. This has to be mentioned in the policy as well. The suggestions were accepted by the Council.

After discussion, the proposed policy was unanimously sanctioned.

**Item No. 5: To discuss about starting selected value added courses.**

Dr. M. M. Karanjkar, Dean , Science Faculty presented the list of value added courses proposed to be introduced in the year 2021-22. He explained the rationale behind choosing the said courses.

The proposed list was finalized for introduction from the year 2021-22.

**Item No. 6: To discuss about the proposal of enlisting Vivek research journal in UGC list.**



Dr. M. M. Karanjkar proposed on behalf of the Research Committee that Vivek research journal be sought to be included in the UGC list so as to fetch good research contributions from the research fraternity to the journal in the future.

The proposal was unanimously sanctioned.

**Item No. 7: Any other matter with the permission of the Chair.**

Dr. S.S. Mahajan, Representative of the University, took a review of the academic journey of the college during the three years of Autonomous Status and enlisted the challenges ahead. He extended wishes to the college for its future academic progress.

As there was no other matter to be discussed, the meeting ended with thanks to the Chair proposed by Dr. M. M. Karanjkar.
