1. DESIGNATION:

You will be designated as "Support Officer."

3. FIXED TERM OF EMPLOYMENT:

Basis your confirmation that you were relieved from the services of your previous employer as of the date of your joining with Bajaj Finance Limited, please note that, your employment with Bajaj Finance Limited will commence tentatively on 13-07-2026 as may be agreed by BFL, in its sole discretion) and will expire on 12-07-2028.

***NOTE:** Subject to BFL's sole discretion, if there is any variance in the date of joining/expiry mentioned above, a fresh Offer letter will be issued recording the actual date of joining, which shall supersede this Offer letter.

4. HOURS AND PLACE OF WORK:

- You will be required to work such hours as may reasonably be expected of you and as is consistent with an appointment of this nature.

5. SALARY:

- e. 7. ANNUAL SALARY REVISION:

- a. We follow a May to April performance cycle. All salary revisions come up for review in the month of May at the sole discretion of the Company.
- b. Employees who have joined the organization on or before 31st July in the current calendar year, may be eligible for a proportionate salary review during May of next calendar year. The increment if any, is dependent on various factors including performance of employee and would be proportionate to the months' of service rendered by the employee. Those joining after 31st July, will not be eligible for the same.

8. PERFORMANCE BASED VARIABLE BONUS/ INCENTIVE:
