Sir/Madam.

This is with reference to the proposal submitted by Vivekanand College, 2130/E, Tarabai Park, Kolhapur-416 003 (Maharastra) affiliated to Shivaji University, Kolhapurunder the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee and on the basis of the recommendations of the Standing Committee, the Commission at its meeting held on 20.03.2018 has decided to grant autonomous status to Vivekanand College, 2130/E, Tarabai Park, Kolhapur-416 003 (Maharastra) affiliated to Shivaji University, Kolhapur, for a period of ten years w.e.f. 2018-2019 to 2027-2028.

Shivaji University, Vidyanagar, Kolhapur-416 004 may issue necessary otification/order regarding the grant of autonomous status to the college as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.ac.in. The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.
