notified thereunder as applicable bearing Corporate Identification Number U80903PN2014NPL151080 and having its registered office at "CTS NO. 72/1 Lane No. 15 Prabhat road, Pune, Maharashtra, India, 411004, herein after referred to as 'OTHER PART'

1. Whereas

1. Majorly Pharmaceutical companies have approached to Yashaswi to extend their support to mobilize apprentice for them.
2. Most of these companies require BSC, Microbiology, Biotechnology, Bioscience fresher candidates either who will be appearing for final examination in 2025 or who have passed out in last two years i.e. 2023&2024.
3. Concerned organizations will conduct interviews in the premises and selected students will be engaged as apprentice for On - the-Job Training (OJT)
4. Duration of the training will be maximum up to 2 years.
5. Selected apprentice will be provided monthly stipend ranging from Rs. 18000/- to Rs. 23,000/- apart from appropriate insurance cover.

Role and Responsibility of the Institute

1. To publicize various requirements
2. To provide list of students who are interested in obtaining Apprenticeship training.
3. To organize counseling session of the students who are interested to participate
