MEMORANDUM OF UNDERSTANDING (MoU)

between

&

This Memorandum of Understanding ("MoU") is entered into on 11.05.2026, by and between,

First Party represented herein by **VIVEKANAND COLLEGE, KOLHAPUR (An Empowered Autonomous Institute)** its Principal, and **Walstar Technologies Pvt.Ltd.** the Second party, and represented herein by its **Director, Walstar Technologies Kolhapur.**

WHEREAS:

A) First Party is a Higher Educational Institution named **VIVEKANAND COLLEGE, KOLHAPUR (An Empowered Autonomous Institute)**

B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

C) The Parties intent to **cooperate** and focus their efforts on cooperation within area of **Skill Based Internship, On the Job Training and Placements for Students**

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall execute activities relevant to agreement.
- 1.4 There will be exchange of training and Real time Project with Placement with **VIVEKANAND COLLEGE, KOLHAPUR (An Empowered Autonomous Institute)** students.
- 1.5 There will be no any financial transaction between both the parties regarding internship and placement

CLAUSE 2

SCOPE OF THE MoU

- 2.1 Industrial Training/ Internship/On the Job Trainings/ Live Projects: **Walstar Technologies Pvt. Ltd., Kolhapur** will provide an insight into the latest developments / technologies / requirements of the industries; the Second Party to permit the Faculty and Students to interact and involve in Industrial Training / Internship. This will provide confidence & smooth transition for students work.
- 2.2 Financial : There is no financial commitment on the part of the **VIVEKANAND COLLEGE, KOLHAPUR (An Empowered Autonomous Institute)** the first party to take up any program mention in MoU.
- 2.3 Both Parties to obtain all internal approvals, consents, permissions, of whatsoever required.

CLAUSE 3

VALIDITY

- 3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms. Any act on the part of both the Parties after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MoU. The validity of the MoU may however be for three years.
- 3.2 Both parties are agreed to go with this MOU up to 5 years with all specified clauses.



CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent persons, and the relationship established under this MOU shall not be construed as a partnership.

4.2 Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by mutual discussion.


