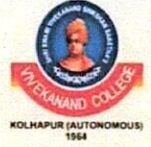


Vivekanand College is a college affiliated to Shivaji University, Kolhapur MS, India and it is a grant-in-aid, co-education college registered under 2(F) and 12 (B) and society act by Govt. of Maharashtra. The college has a Governing Body which is approved by the authority appointed by Govt. of Maharashtra. It runs as per rules and regulations made by the Govt. from time to time.

The college comes under "Grant-in-Aid" category therefore financial transactions are audited by the Government. The college has different committees to maintain discipline in the campus such as Anti-ragging, Discipline, Grievance Redressal Committees etc.

All the cells or committees of the institution are under statutory Bodies and come under section 4 (1) (b) of RTI Act 2005. The application under the RTI Act along with a postal order/demand draft of Rs. 10.00 obtained in favour of Principal, Vivekanand College, Kolhapur (Empowered Autonomous) may be sent to the public information officer (PIO) or handed over in his office.
