Item no. 2: To approve the minutes of Academic Council

The minutes of the two meetings of the Academic Council were read by the Hon'ble Principal. He presented the structure of curriculum under NEP 2.0 . The members were informed about the revised framework of Curriculum as per the guidelines of NEP-2020 (phase 1.0). Also, he informed about the admission process of M.B.A. and M.C.A Part-1 programmes which are newly started in the current academic year. Student response is good. The syllabus and curriculum structure for these programmes was also framed as per NEP-2020 and it was conveyed to the Body. Apart from this, the newly started course in Hotel Management and Tourism Studies and M.A. in Geography was also discussed.

Dr. B. M. Hirdeker suggested the expected changes in M.B.A. curriculum. It was suggested that the curriculum should be of higher quality. He also mentioned that special efforts must be taken to use social media for publicity.

The Chairman Hon. Abhaykumar Salunkhe suggested that a detailed brochure should be prepared in Marathi about all the courses and facilities offered in the college.

Item no. 3: To approve the minutes of Finance Committee

The meeting of Finance Committee was held on 08.02.2024. Minutes of the meeting were read by Prin. Dr. R.R. Kumbhar and confirmed by the members. The details of the expenditure incurred as per the revised budget for the autonomous college grant submitted for the previous financial year was presented to the Body and it was approved by the members. Re-appropriation of budget heads for 2023-24 was also discussed.

Information about Shikshan Maharshi Dr. Bapuji Salunkhe Merit Scholarship to be started at the college level was given to the members. It has been decided to give scholarships of Rs. 5000, 3000 and 2000 respectively to the first three students (classwise and branch-wise) in the college and provision has been made in the budget for this. Accordingly, Dr. Bapuji Salunkhe Merit Scholarship was approved by the members.

Item no. 4: To approve the minutes of the CDC

The meeting of CDC was held on 08.05.2024. Its minutes were read by Prin. R. R. Kumbhar and were confirmed by the Governing Body.

The principal pointed out the urgency to provide physical facilities for the newly started M.B.A. and M.C.A. programmes and increased divisions of BCA and BCS.

Dr. B.M. Hirdekar brought to notice that the staff appointed for training and placement must have all the information about the scholarships and they should create awareness about the same among the students and the parents.

Dr. Shejwal suggested that an induction program of one week should be taken for this.

Dr. Hirdekar suggested that all the autonomous colleges should jointly follow up with the university and try to get the university merit scholarship as before. He further added that the Alumni must be implored to contribute to starting new scholarships and thus, add to the corpus fund.

Hon. Principal brought to the notice of the Board that the staff appointed for newly started M.B.A. and M.C.A programs should be paid as per AICTE rules. He also informed that the non-teaching staff appointed to P.G. and other self-supporting programmes have a demand for increased remuneration. On this, Hon. Chairman suggested that their demand should be approved and the remuneration should be given as per rules and proper documentation should be maintained. He further mentioned that a policy of frugality should be adopted while paying remuneration as per rules.

While discussing the infrastructural requirements for M.B.A. and M.C.A., Hon. Abhaykumar Salunkhe, the management Representative, said that it is not possible to construct a new building at the site of the college library. However, a six floored building can be proposed with AICTE standards at another location in the campus.

Item no. 5: To approve the minutes of the IQAC

The meeting of IQAC was held on 08.05.2024. The minutes of this meeting were read out by IQAC Coordinator Dr. Shruti Joshi and confirmed by the members. The achievements of students-teachers and activities conducted during the academic year 2023-24 by IQAC were reported.

Dr. B.M. Hirdekar suggested to increase the number of MOOCs to be launched on the college LMS platform.

Further, the college is facing NAAC for the 4th cycle on 14th and 15th October 2024. The preparations for the same were reviewed. The members were informed that so far three mock peer team visits have been conducted and on 3rd, 4th and 5th October, the $4^{\rm th}$ Mock will be taken which includes Peer Team members :

Item no. 6: Any other matter with the permission of the Chair.

- 1) It was discussed about starting the following four new postgraduate programmes in the college from the academic year 2025-26.
- 1. M.Sc. Zoology
- 2. M.Sc. Geoinformatics
- 3. Masters in Rural Studies
- 4. Masters in Correctional Administration

It was decided to send the necessary proposal to the university to start the programmes.

- 2) The Principal informed the members that according to the decision of the Government of Maharashtra, the process has been started at the institution level to fill the 27 posts of teachers approved for the Autonomous College.
- 3) As per the UGC guidelines, the anointed term of three years of the present governing body has expired. A new governing body will be constituted for the academic year 2024-25 to 2026-27. However, in the last 3 years, all the members have given valuable guidance to the college administration, and as a result, the college is making progress in all the fields. The principal expressed our gratitude by thanking everyone for their contribution through these years.

All the honourable members gave best wishes to the the College staff for impending the peer team visit of NAAC.

As there was no other matter to discuss, a vote of thanks was proposed by Prin. Dr. R. R. Kumbhar and the meeting ended with the permission of the Chairman.
