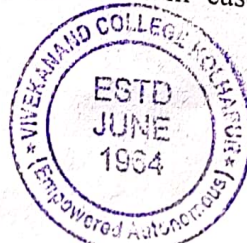
The following topics were discussed in detail at the meeting and accordingly the resolutions were unanimously approved.

Subject No.1: To enlighten the members of the committee as per the purpose behind forming the committee.

Committee member Dr.D. R. Tupe vides University Circular no. As per Special Room/362/2023-24 dated 27.09.2023, a committee has been constituted in the college and its main objective is to prevent such incidents if caste-based discrimination is being done among the staff or students in the college. It was mentioned that this committee will be working in the college so that no discrimination or injustice will be done to anyone as a backward class. Everyone gave information about the responsibilities as a committee member.

Subject No.: 2 Planning preventive measures against caste discrimination among faculty and staff.

Committee Member Shri. Amar Jadhav, while giving information about this, said that no inappropriate incident of caste-based discrimination has happened in our college lately, but there is a very harmonious atmosphere in our college. However, the members were told in detail how to plan preventive measures to be taken in case such an incident happens unintentionally in the future.



Subject No. 3: Any other matter with the permission of Chair person

In this, the initiative started by the university from the members is very good and it will help in creating a good atmosphere in the colleges. In order to inform all the students and staff about this committee, a board should be prepared with the name and contact number of the members of the committee and it should be put up in the visible place, at least two meetings should be organized in a year, one per semester, and also the information and minutes of the committee should be published on the college website from time to time. . Chairman of the committee, Dr. G.S. Ubale said immediately implementing all the received suggestions.
