### **Item No.1: Confirmation of minutes of previous meeting**

### **Item No. 2 : To discuss on academic/ Examination/Governance grievance cases held in second term of academic year 2022-23**

It was decided to take action against grievances found in second term of academic year 2022-23 , the grievances are as follows with action taken

- i) In first term some students from BCA , B.Sc. and PG paid extra fees so their fees are adjusted in second term examination
- ii) Due to college dues some students did not fill exam form. After discussion with Principal sir it is decided to allow these students for exam with undertaking
- iii) To arrange out of turn practical exam for those students who fail to attempt practical examination due to genuine reason
