Item 2. To discuss on organization of various activities in Second Term

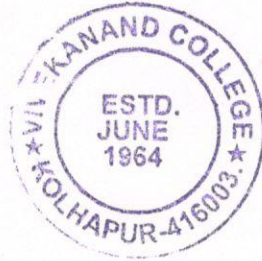
It was decided to organize 2 awareness programs for students in second term.
